BIOGRAPHY

Grace V. S. Chin is Senior Lecturer in English Language Studies at Universiti Sains Malaysia, and the Editor-in-Chief of *International Journal of Asia Pacific Studies* (<https://ijaps.usm.my/>), an award-winning journal indexed with Scopus and ESCI. Using comparative and multidisciplinary approaches, she specialises in postcolonial Southeast Asian Anglophone literatures, with focus on the intersections of race, gender and/or class in contemporary societies and diasporas. A recipient of numerous grants and fellowships, Dr Chin was awarded senior fellowship in 2016 by the Royal Netherlands Institute of Southeast Asian and Caribbean Studies (KITLV) in Leiden. She has also been affiliated to numerous international institutions as a visiting scholar, including the Ateneo de Manila University, University of Philippines Diliman, Universiti Brunei Darussalam, Universitas Indonesia, and National Institute of Education, Nanyang Technological University, in Singapore.

Her works are featured in refereed journals indexed in Scopus and Web of Science, including *Textual Practice*, *Lit: Literature Interpretation Theory*, *Journal of Postcolonial Writing*, *The Journal of Commonwealth Literature*, *Journal of Transnational American Studies*, *Journal of Southeast Asian Studies*, *SARE Southeast Asian Review of English*, *GEMA Online Journal of Language Studies*, and others. She has moreover co-guest edited special issues, viz. *Journal of Postcolonial Writing*, *World Englishes*, and *KEMANUSIAAN The Asian Journal of Humanities*, as well as published (co)edited book-length volumes with ISEAS Publishing, Springer and Routledge.
