BIOGRAPHY

JASNI BIN SULONG adalah Profesor Madya di Bahagian Pengajian Islam, Pusat Pengajian Ilmu Kemanusiaan, Universiti Sains Malaysia. Beliau mula berkhidmat di Universiti Sains Malaysia sejak Februari 2006 sehingga sekarang. Berkelulusan Sarjana Muda Syariah (1998), Sarjana Syariah (2001) dan PhD Syariah (2006) dari Akademi Pengajian Islam, Universiti Malaya. Merupakan Dekan Pusat Pengajian Ilmu Kemanusiaan (April 2021-Dis 2024). Sebelumnya pernah menyandang jawatan Timbalan Dekan (Akademik, Kerjaya dan Antarabangsa Pusat Pengajian Ilmu Kemanusiaan (2019-2021). Beliau juga dilantik sebagai Felo Kanan Pusat Kajian Pengurusan Pembangunan Islam (ISDEV), Universiti Sains Malaysia sejak tahun 2008. Kajian beliau banyak dilakukan dalam bidang pentadbiran undang-undang pusaka, wasiat, wakaf dan hibah; sementara dalam pengajaran terfokus kepada ilmu khusus syariah khususnya Usul Fekah, muamalat dan kekeluargaan Islam.. Di peringkat negeri, beliau pernah dilantik sebagai Ahli Jawatankuasa Fatwa Negeri Pulau Pinang (2023), Ahli Jawatankuasa Teknikal Undang-Undang Syariah Negeri Pulau Pinang (2016-2025), Ahli Jawatankuasa Penyelidikan Zakat Pulau Pinang (2021-2023) dan penceramah jemputan di Radio Mutiara FM bagi bagi slot rancangan “usrati” pada setiap hari khamis yang membincangkan persoalan undang-undang kekeluargaan Islam (2018-2024). Manakala di peringkat kebangsaan, beliau sekrang adalah Penasihat Syariah di as-Salihin Trustee Berhad (mulai Nov. 2023) dan juga di MediCap Sdn. Bhd. (mulai Mac 2022). Kepakaran beliau dalam bidang syariah menyebabkan Dr Jasni pernah dilantik sebagai Penilai Program Pengajian Islam di Universiti Kebangsaan Malaysia (Sarjana Muda dan Sarjana), Universiti Selangor (Sarjana Muda) dan Kolej Universiti Perlis (Sarjana Muda).
